E. CBTF POLICIES & RULES APPLICABLE TO THE TERMS OF THIS CONTRACT

- a) Emergency situations requiring release from a contract warrant due notice and immediate notification to the Competition Director. The Competition Director may request a substitute replacement. Judges who fail to honour a signed contract without acceptable notification may be subject to a penalty. Monetary fines as deemed necessary by the Competition Director may be charged. A CBTF Record of Violation must be filled out and sent to the CBTF Judges Representative.
- b) If a CBTF Judge judges an event(s) at a CBTF Sanctioned Competition (exception: Type C Competitions) and is not certified to do so, he/she shall be fined \$100.00. If this action is repeated, he/she shall be suspended from judging at CBTF competitions.
- c) All competitions sanctioned by the CBTF are to run in accordance with the strict standards as set forth within CBTF Policies and Regulations.
